- ▶ Influence the national market towards high efficiency

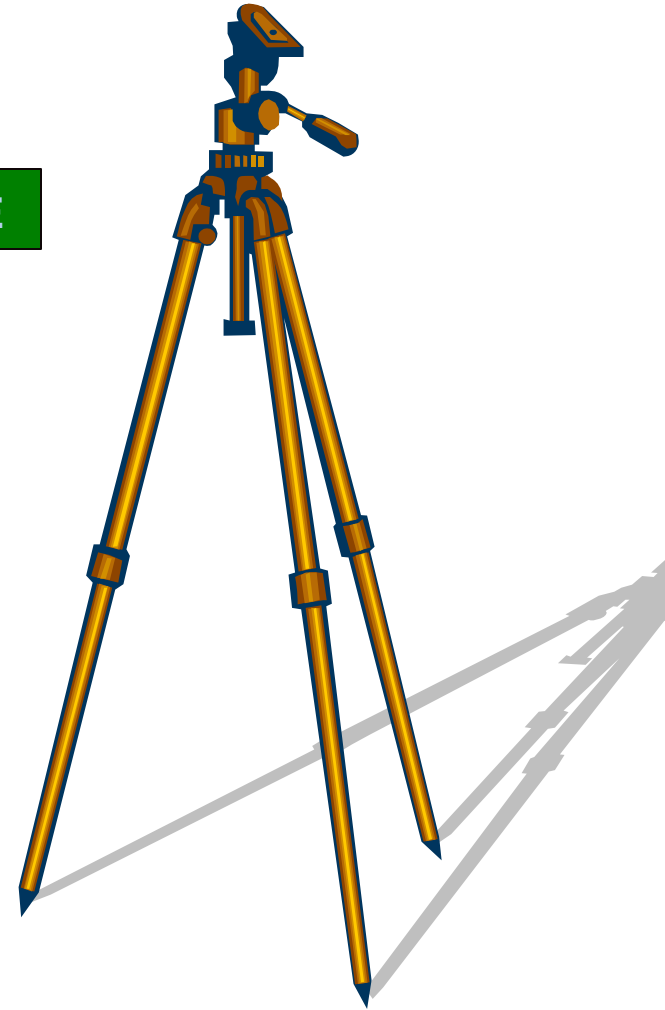
The “Tripod” Approach

2. Quality Installation

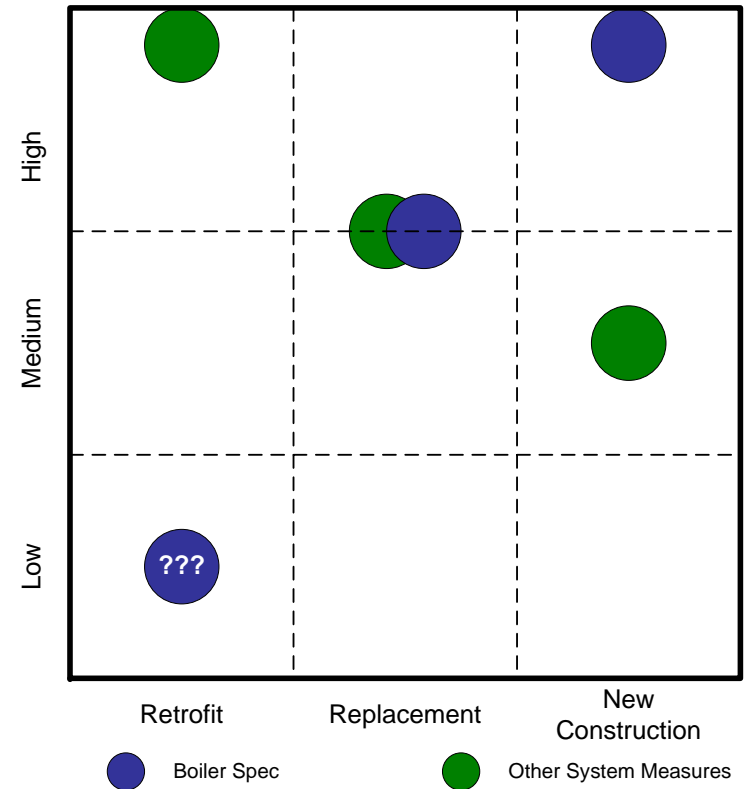
3. Operations and

Targeting the Market

Section 2: Scope/Product Definition

▶ Potential Considerations

- Application: Should we focus on both space and hot water heating?
- Capacity: What is the upper limit?
- Building Type: Should we target specific markets?
