Wastewater Treatment Plant

North Tonawanda, Niagara County

The City of North Tonawanda is located in southern Niagara County and has a population of approximately 35,000. The City operates a 20 mgd wastewater treatment plant (WWTP) with an average daily flow of 7.5 mgd. The plant consists of influent pumping, grit removal, primary clarification, sand filtration, carbon adsorption, and chlorine disinfection.

An energy evaluation study was undertaken to identify, evaluate, and determine energy savings through process wastewater, heating, and ventilation modifications. The New York State Energy Research and Development Authority's (NYSERDA's) FlexTech Program provided cost sharing on the project through one of its consultants, Stearns & Wheler, LLC.

The study provided a comprehensive review of the North Tonawanda Wastewater Treatment Plant and recommended energy conservation measures throughout the facility. These measures included load shedding, equipment replacement, and HVAC alternatives. If all recommended measures were installed, the treatment plant could expect to see a savings of \$211,000 with a capital cost of \$771,000, providing a simple payback of less than 4 years.
